All members of the Board were present except Director Bramlett, thus constituting a quorum.

Also in attendance were: Jeff Hass of Texanna Builders; David Borgmeyer of Texas Aquatic Enterprises; Randy Risher, Tina Deases, and Steven Wright of The Risher Companies, the District's Recreation Manager ("Risher"); Bill Sweitzer of Sweitzer and Associates, the District's Landscape Architect ("Sweitzer"); Chris Roznovsky and Diego Burgos of Jones & Carter, the District's Engineer ("J&C" or "Engineer"); and Mallory Craig, Attorney of Coats|Rose, P.C., the District's legal counsel ("Coats|Rose").

WHEREUPON, the meeting was called to order at 7:00 a.m. in accordance with the posted meeting notice, which is attached hereto as Exhibit "A".

HEAR FROM LANDSCAPE ARCHITECT

The Board then recognized Mr. Sweitzer, who presented and reviewed the proposed Change Orders, copies of which are attached hereto as Exhibit "B".

The Board reviewed the change orders presented and upon a motion by Director Simmons and seconded by Director T. Craig, the Board approved the following Change Orders and revisions thereto:

• Change Order 11 with Sweitzer paying the cost of Change Order 11, minus the final amounts owed for design work relating to the project, for a total of \$2,862.20;

- Change Order 12, with no revisions or conditions;
- Change Order 15, with Sweitzer paying the full cost of Change Order 15;
- Change Order 17, with Sweitzer paying the full cost of Change Order 17;
- Change Order 18, with no revisions or conditions; and
- Change Order 21, with no revisions or conditions.

Pursuant to the Board action above, Sweitzer will be responsible for paying a total of \$7,473.70 towards the Change Orders and Contract Price.

HEAR ENGINEER'S REPORT

No action was taken.

RECREATION COMMITTEE

The Board discussed reconstituting the Recreation Committee. Upon a motion by Director Simmons, seconded by Director T. Craig, the Board voted unanimously to reconstitute the Recreation Committee to include Director Hebert and Director Warren.

At this time Director Hebert left the meeting to attend to prior commitments.

The Board then discussed authorizing the Recreation Committee to approve Change Orders and equipment purchases. Upon a motion by Director Simmons, seconded by Director Warren, the Board authorized the Recreation Committee to (i) approve Change Orders and/or equipment purchases in an amount not to exceed \$7,500 per Change Order or equipment purchase, (ii) approve an aggregate amount of Change Orders and/or equipment purchases not to exceed \$20,000 between regularly scheduled Board meetings, and (iii) provide a detailed report to the Board at each meeting of all Change Orders and/or equipment purchases approved.

There being no other business to come before the Board, the meeting was adjourned.
